- 1. Install the BGlobal WhatsApp package.
- 1. Request support to enable anonymous authentication then follow the instructions in Additional Resources (<u>See step\_by\_step\_WS.pdf</u>).
- 1. Go to Studio Workplace.
- 1. Go to the BGlobal WhatsApp Chat Settings section.
- 1. Click on + Bglobal WhatsApp Chat channel.
- 1. Complete the following information:
- a- Name = Reference name for the channel.
- b- API Token = token provided by Meta.
- c- API Phone Number Id = value provided by Meta.
- d- Whatsapp Account Id = value provided by Meta.
- e- Enable logs: you should check it if you want to enable logging.

f- Verification URL and Verification Token: Copy and paste this information into Meta after saving the channel.

Also:

- Once the channel is created, you can click on it and change the Chat queue associated with it. Ensure that the agents are in the corresponding queue.
- You can copy the channel to use the same Meta App but using different phone numbers.
